TAX TIME REMINDERS

APRIL
15

The deadline to file your 2025 taxes is Wednesday, April 15, 2026.

FORM 1098 & FORM 1099-INT Members who earned a minimum of \$10 in dividends will receive a Form 1099-INT. For members who have a HELOC or mortgage, you will receive a Form 1098. These forms will be mailed to you by January 31, 2026. Tax forms can also be downloaded through our online banking. **EXPECTING A TAX REFUND THIS YEAR?** Use our **ROUTING NUMBER 321378990** and get it directly deposited into your Hawaii Central account! **CONTRIBUTE TO AN IRA** It's not too late to contribute to your Individual Retirement Account (IRA) for the 2025 tax year. The standard limit is \$7,000 but if you are over the age of 50, your limit is \$8,000.

Updated Fees

Beginning January 2, 2026

Auto, Personal, Line of Credit and Homeowner's LOC will be charged a late fee if you are more than 15 days past due on your loan payment. The late fee will be 5% of your scheduled monthly payment.
